- **Preaching & Worship:** Organize weekly worship services in collaboration with music and worship leaders for a cohesive, engaging experience. Develop and deliver sermons that communicate biblical teachings for everyday life. Plan for and provide leadership in the observance of the Lord's Supper and baptisms.
- *Missions & Outreach:* Spearhead successful missions and care ministries programs in both the church and local community. Conduct regular visits to local mission partners to foster meaningful engagement. Establish and nurture the church's mission partnerships, seeking opportunities to amplify their impact across the congregation. Proactively visit with prospective members to invite and integrate them into the church.
- Administration & Leadership: Supervise a staff of professionals, including Associate Pastors, administrative staff, and the Director of the FBC Early Learning Center (ELC). Give leadership to all Human Resources and Personnel functions alongside the Personnel Committee, including creating and maintaining personnel policy handbooks, leading weekly staff meetings and other internal communication initiatives, performing staff recruitment and hiring, conducting evaluations, ensuring competitive staff compensation, and maintaining accurate and confidential records. Serve as chairperson of the Church Council to plan, organize, direct, coordinate, and evaluate regular church programs and special events. Facilitate the church through an intentional ReShape process with Pinnacle Leadership Associates, meeting in small groups to re-imagine ministry in a new age with significant, transformative outcomes.
- *Finances & Stewardship*: Manage and fundraise a total church budget of \$1 million alongside the staff and committees, which includes the Early Learning Center budget (\$500,000). Emphasize year-round stewardship with a narrative ministry plan sent to donors with the line-item budget. Communicate quarterly with givers on goals and pledges. Work with Trustees to better manage our invested funds money market accounts for money in checking accounts and creation of a singular church endowment. Plan legacy giving seminars. Meet with relevant committees and staff to manage the church building as an asset (beyond the expansion of the ELC), finding ways to share empty space to support our church ministry budgets and serve our community.
- **Pastoral & Counseling:** Conduct weekly hospital and homebound visits. Provide pastoral counseling as needs arise. Counsel baptismal candidates, assist in funeral and wedding planning, and provide pre-marital counseling. Work closely with deacons, church officers, and committees, providing guidance and support as they fulfill their assigned responsibilities. Train the deacons in a comprehensive family ministry program.

- Communications & Technology: Design and implement a comprehensive church communication strategy, catering to both internal church contacts and community outreach. Oversaw the launch of a new church website and logo that provides a visually appealing and user-friendly online presence. Share sermon and worship service audio/video content, revamped the church newsletter and maintain an active blog, and use social media to share church news and information to our broader audience. With appropriate committees, created audio-visual systems for worship and meetings, oversaw the complete overhaul of our Wi-Fi and security systems.
- Denominational & Community Engagement: Facilitate deeper connections between the church and Cooperative Baptist Fellowship (CBF), inviting field personnel missionaries to share their experiences, and becoming an encourager church for two field personnel. Play a pivotal role alongside Rev. Charles Whitfield, a local Black Baptist pastor, in co-leading community initiatives for justice, including a solidarity march, co-authoring op-eds in the local newspaper, facilitating diversity, equity, and inclusion (DEI) trainings, and forging ongoing partnerships with local companies to address issues of race and race relations.
